Our insurance Broker is currently working on the yearly insurance premium. Foster Parks will be charging \$27.05 for the months of April and May 2020. This amount is payable by April 30, 2020. If you are an "active" day home provider, this premium will be deducted from your provider's cheque at the end of the month. If your day home is currently "inactive, you will need to make arrangements with your Consultant for payment before the above due date.

Once the yearly insurance premium (June 2020 – May 2021) is finalized, the payment will be due on May 29, 2020. The yearly premium is estimated at \$158.00. There may be an adjustment to this premium. Payment will be required as stated above.

Insurance certificates will be distributed as soon as possible. The Agency will continue to update the Educators as more information is available.

Assertive Language

When speaking to parents be prepared. Some ways to prepare are:

Know what you are going to say (Role play and practice with a friend of partner)

Have reference materials. (Signed Agreements and Provider Handbook)

Use I messages: "I understand this is a difficult time but according to the agreement it is 2 week written notice or payment in lieu of notice".

Come to a clear mutually agreed upon decision and inform the agency.

Children Absent from the Dayhome

The parent fee is paid in order to reserve a space in the day home. If the Children are absent from the day home because of illness or for any other reason whatsoever, the fee is due and payable on the same terms and conditions as if the Children were present. If provider is unable to give care, then parents will be credited or referred to back up educators.

Please remind Parents if children are absent fees are still charged and due.

Please email consultants any diagnosis for CoVid-19 as we are suppose to report any cases to our child care licensing officer. The diagnosis includes the following people:


- ⇒ Children in care
